Progress the jurisdiction has made in carrying out its strategic plan and its action plan. 91.520(a)

This could be an overview that includes major initiatives and highlights that were proposed and executed throughout the program year.

The City of Pflugerville is a fast growing suburban community that is home to over 56,000 residents. Pflugerville traditionally has been a suburban bedroom community, but is quickly becoming a full service city; providing not only places to live but to work, shop and play.

The City's overall development objective is to support the key goals outlined in the Consolidated and Annual Action Plan. In 2015, Pflugerville continued its efforts to expand residents' choices and opportunities by providing youth scholarships for city recreation programs and by making improvements to public infrastructure and facilities. The City completed several projects outlined in its PY2015 Action Plan, including a primary project identified in PY2014 Annual Action Plan. The City also successfully completed a sidewalk preoject identified in PY 2014 Annual Action Plan. Completed preojects included the implementation of a youth recreation scholarship program and construction of phase I of the city's sidewalk improvement project. As a result residents are able to enjoy the newly constrctued sidewalks located on Foothill Farms Loop and Edgemere Drive as well as sidewalk infrastructure located at the Recreation Center that were installed in an effort to improve accessibility and access for seniors and the disabled.

The City of Pflugerville has demonstrated measurable progress in its efforts to launch the projects outlined in its PY2015 Annual Action Plan. Because of changes in property availability an amended 2015 Action Plan was completed in the summer of 2016 identifying additional CDBG eligible projects. Those additional projects, include sidewalk construction projects which are underway and will continue to be pursued in order to fulfill the needs of the community.

Assess how the jurisdiction’s use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.

In the 2015-16 program year, fifty-three (55) children living in low to moderate include households were approved to receive youth recreation scholarships, which allowed them to participate in eligible recreation programs. Forty-three (43) of the approved children utilized the scholarship. The youth scholarship program allowed recipients access to a variety of recreation programs, such as the Pflugerville Summer Pfun Camp, and swim lessons being the most popular. The total cost to implement the scholarship program totaled \$5,862.00.

Phase I of the Sidewalk Improvements project neared completion in the Fall of 2016. CDBG Funds were used to replace deteriorated sidewalks and add the sidewalk system at Edgemere Dr. In addition, a connecting sidewalk was constructed along Foothills Farms, thereby providing for additional safe pedestrian access to, among other destinations, the Travis County Health & Human services site. CDBG funds were also utilized to construct a new sidewalk and accessible ramp and entrance at the rear entrance (west) of the Recreation Center. Final closeout of the sidewalk preojects are expected by the end of calendar year 2016 with the final installation of an accessible door to the Recreation Center. The total cost for these improvements is \$94,801.24.

One of the original PY2105 projects included the acquisition of parkland along Parkway Drive. After the Action Plan was completed however, the

proposed parkland property was purchased by a third party. The loss of this project required the City to reallocate funds and pursue other projects that met the objectives of the CDBG program. In the summer of 2016 the City submitted an amended Action Plan identifying new projects to be pursued. Design is currently underway for the first of the additional projects identified, the Gatlinburg Sidewalk Improvements project, which is anticipated to be completed in the Spring of 2017. The other project identified in the Amended 2015 Action Plan, the construction of Senior Park and Bohls Park, will not be pursued as a CDBG project because of the use restrictions that would need to be imposed in order to ensure that the project remained CDBG-eligible. The City will continue to pursue additional CDBG-eligible projects that meet the objectives outlined in the City's five year Consolidated Plan.

Narrative

Infrastructure and public facility CDBG projects, such as phase one (1) of the Sidewalk Improvements project, are limited to tract and block groups that have a threshold of LMI persons/families of 41.44% or higher. The Sidewalk Improvements project encompassed tract 1860 block group 1 (Edgemere), tract 1860 block group 2 (Foothills Farm) and Tract 1841 block group 4 (Senior Recreation Center).

Projects such as the youth scholarship program are applicable to each tract and block group in Pflugerville. To qualify for and receive the scholarship award, a child has to meet all requirements listed in the application, regardless of where they reside within city limits. CDBG projects benefitting presumed LMI residnets such as seniors and disabled individuals are applicable to all tract and block groups.

To date neither the county social services, nor other known social services groups have identified or expended resources towards addressing homelessness. In addition, no known transient population is within Pflugerville in need of services. However, the City will continue to coordinate with the ECHO to become more knowledgeable about the needs of those who are homeless within our community. Should circumstances change regarding homeless needs with the City of Pflugerville staff will reevaluate the use of CDBG funds to address identified needs.

In February of 2015, the City adopted an updated Unified Development Code (UDC). The UDC outlines the required regulations for all development within the City. In order to provide a greater mix of housing opportunities within the community, the City's updated UDC allows for a variety of housing options. The 2015 UDC allows for greater flexibility in lot sizes (small to large lots), housing types (single family, multi-family, condominiums, and townhomes) and clearly defines the architectural and other building requirements. By allowing smaller lot and higher density residential developments, the City hopes to provide developers with the opportunity to construct more affordable housing.

Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

Potential obstacles to meeting underserved needs include: rapid population growth, the need for a variety of transit options to existing services, access to affordable recreation facilities and programs, and the rising cost of housing. While the City of Pflugerville's population will continue to rise, the City has undertaken various planning processes to help manage that growth over time. These planning processes have addressed a variety of growth related concerns, including but not limited to: water, wastewater, parks, trails, land use, and housing. Selected projects will complement the long term plans for a growing city that aid in meeting underserved needs of the low to moderate income population. The projects selected and implemented in PY2015 were chosen to help to provide more affordable and accessible facilities and infrastructure within the community.

Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

The City utilizes the community services provided by Travis County in order to remediate any lead based paint found in Pflugerville's housing supply. Approximately 226 homes within the City of Pflugerville were constructed during the time when lead based paint was accepted for use. The City will continue to utilize Travis County Health and Human Services and Veterans Services, which receives funds through State grants and the Travis County General Fund to provide limited and as needed lead based paint remediation on houses built before 1978.

Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

Approximately 10.4% of Pflugerville residents live in poverty (ACS 2014 5 year estimate). Female headed households with children are particularly affected by poverty. The City's anti-poverty strategy is based on attracting a range of businesses, on providing workforce development, and on offering a mix of uses throughout the community. These strategies support each other and help to reduce or eliminate the need to find housing, employment or services outside of the community. These strategies are reflected in the City's Unified Development Code (UDC) and policies of the Pflugerville Community Development Corporation's policies for attracting employment to the community.

Actions taken to develop institutional structure. 91.220(k); 91.320(j)

The key departments and agencies that are involved in the implementation of the plan are described below.

Public Sector 1) City of Pflugerville's Planning Department (responsible for the administration of the City's Community Development Block Grant (CDBG) grants. The office has primary responsibility for managing and implementing the City's Consolidated/Annual Action Plan programs and related documents); **2)** City of Pflugerville, Finance Department (manages the entitlement grants (CDBG) procurement processes for commodities, professional services and construction. Expertise in the area of federal standards has been created within the department. The department submits all financial reports, including the SF-425.); **3)** Travis County Health & Human Services and Veterans Services Department (TCHHS/VS)(offers a variety of Services to Pflugerville and Travis County residents including: Utility, Rent and Mortgage Assistance, Family Assistance, Children's Services, Senior Services, Public Health Services, and Emergency Services).

The City is committed to continuing its participation and coordination with federal, state, county and local agencies as well as with the private and non-profit sector, to serve the needs of target income individuals and families in the community. The City will continue to work with the area service providers and with the building industry to address housing and community needs.

Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

The City is working to improve communications with existing social service agencies and maintains an open dialogue with public and private housing agencies within the central Texas region. The City consults with various social service agency before and after the selection of projects to determine whether the current needs are still the same as the ones originally identified and, when necessary recommend adjustments. We strive to remain faithful to the goals of the Consolidated Plan while being mindful of budget constraints.

Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)

People of protected classes need quality information about all neighborhood and housing options that are available to them, as well as the tools to overcome real and perceived barriers in the housing market.

In response to these impediments, the City of Pflugerville has prioritized the following as actions to be taken to achieve Fair Housing Choice and Equal Opportunity:

- The City of Pflugerville will provide staff with the latest training and education on the Fair Housing regulations.
- City staff will work with HUD to provide information on how to better assist persons with special needs and disabilities.
- The Community Development Block Grant (“CDBG”) has listed infrastructure projects to accommodate persons with disabilities and special needs. The City will allocate CDBG funds to update sidewalks to ADA standards, and improve pedestrian connections to reduce barriers for the disabled.
- The City of Pflugerville will refresh the community development website to provide links to local, state, and national housing authorities. Housing authorities that will be available online are the Department of Housing and Urban Development (“HUD”), Texas Workforce Commission (“TWC”) and Texas Department of Housing & Community Affairs (“TDHCA”).
- City staff will make publicly available information and forms on fair housing readily available to people with special needs and Limited English Proficiency (LEP).
- City staff will provide Fair Housing complaint forms online and will provide information about the complaint process. The City will also distribute hard copies to local public service agencies to aid residents in filing a complaint with HUD.
- Texas Department of Housing and Community Affairs requires five hours of approved Fair Housing training for architects, developers, engineers, management companies responsible for fair housing compliance. City staff will provide information on TDHCA recommended Fair Housing training opportunities via the City of Pflugerville community development website.

CR-40 - Monitoring 91.220 and 91.230

Describe the standards and procedures used to monitor activities carried out in furtherance of the plan and used to ensure long-term compliance with requirements of the programs involved, including minority business outreach and the comprehensive planning requirements

As the lead agency for the development and implementation of the Consolidated/Annual Action Plan, the Planning Department implements standard policies and procedures for monitoring the implementation of CDBG projects. Monitoring activities included weekly staff meetings to discuss the status of the CDBG projects, weekly site visits to project locations, and close out interviews with contracted construction employees. Additionally, Planning Department staff coordinate closely with other city departments regarding the progress of CDBG projects such as the Youth Scholarship Program. Parks and Planning staff discuss new applications for the scholarship program weekly and planning staff reviews and verified them as they are processed by the Parks Department through a shared drive and coordinates with the Parks staff should any questions or concerns arise regarding the eligibility of a scholarship recipient.

These monitoring activities are in compliance with both program regulations and financial requirements.

Citizens are invited to comment on all performance reports. Notices of issued reports are published in the local newspapers, the City website, City's electronic newsletter, information placed at the Public Library as well as through the Travis County Community Center. Notices are issued at the beginning of the comment period as well as throughout the fifteen day review and comment period.

At its December 13, 2016 City Council meeting, the City held a public hearing where PY2015 accomplishments were reviewed. No public comment was received.

CR-45 - CDBG 91.520(c)

Specify the nature of, and reasons for, any changes in the jurisdiction's program objectives and indications of how the jurisdiction would change its programs as a result of its experiences.

The City amended the 2015 Action Plan to accommodate the changes in land availability for the originally anticipated parkland acquisition. In Pflugerville, there are very few areas in which at least fifty percent (50%) of the residents or areas are of LMI and therefore Pflugerville was granted an exception by HUD that allows the City to plan projects in areas that have a LMI threshold of 41.44%.

The amended 2015 Action Plan was updated to add two projects, Gatlinburg Sidewalk and Senior Park at Bohls Park. The new projects focused on infrastructure that would improve mobility within the community and a project that would help address the needs of a growing senior population. Unfortunately, as discussed previously, after submittal it was determined that the Senior Park at Bohls Park would not meet all of the federal objectives of the CDBG program.

In the summer of 2016, the City Council approved the amended 2015 Annual Action Plan which addresses the needs of LMI persons as required by the five year Consolidated Plan.
